# CAITLYN STARK GRADUATES U.S. CHAMBER LEADS PROGRAM

Following a competitive application and selection process, Cadillac Area Chamber of Commerce President Caitlyn Stark was selected



along with 34 other state and local chamber executives, economic development professionals, association leaders to participate in the seventh class of this program.

The six-month program, consisting of in-person and virtual meetings, covered the entire talent pipeline, including early childhood education, K-12, postsecondary education, and workforce development.

This cohort of association leaders from across the country discussed and evaluated child care to transitional career experiences in the education field. National experts in the workforce development industry led this program to share best practices and trends so that up-and-coming leaders can develop solutions for future needs.

### NMCA SECURES MILLIONS FOR WORKFORCE DEVELOPMENT INITIATIVES

Alliance Partners have already scored big wins in a supplemental budget signed into law this March. We worked closely with Sen. John Damoose to secure nearly \$10 million to help build and expand career and technical education programs at North Central Michigan College and almost \$4 million to bolster Northwestern Michigan College's aviation program.

As the NMCA grows our presence in Lansing, we continue to achieve significant investments in workforce development initiatives.

## ALLIANCE PARTNERS APPOINTED TO STATEWIDE HOUSING BOARDS

Two Alliance Partners this year were appointed to critical housing authority positions. Gov. Whitmer made the appointments and announced via press release:

Nikki Devitt of Petoskey is the president of the Petoskey Regional Chamber of Commerce, a founding member of the Little Traverse Bay Housing Partnership. She serves as trustee for the Petoskey Education Foundation and serves on the board of directors for the Michigan Association of Chamber Professionals. Nikki graduated from Caro



Community High School and received her IOM certification in nonprofit management from the U.S. Chamber of Commerce Institute for Organization Management. Ms. Devitt is appointed to represent business advocacy organizations for a term commencing March 9, 2023, and expiring September 6, 2024.

The partnership's primary responsibility is to develop a strategy to implement the Michigan Statewide Housing Plan released in 2022 and make recommendations to MSHDA on how best to achieve its goals.



Warren Call, of Traverse City, is President and CEO of Traverse Connect. He holds a Bachelor of Arts in History from Michigan State University and a Master of Business Administration in International Finance from St. John's University. Mr. Call is appointed for a term commencing February 23, 2023, and expiring March 10, 2026. He succeeds Deborah Muchmore

whose term has expired.

The Michigan State Housing Development Authority, established in 1966, was created to provide financial and technical assistance through public and private partnerships to create and preserve safe and decent affordable housing, engage in community economic development activities, develop vibrant cities, towns, and villages, and address homeless issues.
