ALLIANCE ASSISTS SMALL BUSINESS FIGHT AGAINST "DE MINIMIS" TRADE LOOPHOLE

Alliance partners have joined the fight against a trade exception known as de minimis that allows foreign import products into the U.S. without duties or tariffs and threatens domestic manufacturers who cannot compete with these low-cost imports. Bob Brammer, third generation owner of local manufacturer and distributor Stromberg Carlson, reached out to the Northern Michigan Chamber Alliance to raise a red flag on the trade loophole to federal legislators. The Alliance connected Brammer with Michigan First District Congressman Jack Bergman and alerted the Michigan Chamber of Commerce to get the issue on its radar.

"It's getting the attention of more and more legislators ... it's starting to get some traction," said Warren Call. "We've left the door cracked open, and they've slipped through it in a big way... It's not something that impacts all of the companies in Northern Michigan, but the ones it impacts, like (Stromberg Carlson), it impacts in a big way."
